Terms and Conditions for Registration/Renewal of Child Care Institutions in Karnataka

1. This Certificate is non-transferable and subject to immediate return to the Registration Authority in the event of closure of the organisation (it will have no effect during the period of withdrawal).
2. Any change of address of the Organisation / Institution shall be intimated to the Registration Authority.
3. It shall scrupulously follow: (i) Section 41(1) of Juvenile Justice (Care & Protection of Children) Act, 2015.
4. The organisation shall maintain all necessary records/registers and documents as per the Juvenile Justice (Care and Protection) Act and Rules.
5. The organisation shall be subject to inspection by the officers of the Department Women and Child Development or any inspection committee approved by State Government.
6. The Registration Certificate does not authorise the organisation to deal with adoption for which separate license should be obtained from the State Government.
7. This Certificate along with conditions shall be displayed in a conspicuous place in the Office of the organisation.
8. The Institution shall be duty bound to admit children subject to the capacity of the institution.
9. The Registration of the organisation shall be renewed once in every five years. The Organisation shall obtain renewal before the expiry of the validity period.
10. The registration shall be liable to be withdrawn if the Registration Authority receives complaints of any malpractice/ improper functioning / misuse of funds / poor quality of care and services to children.
11. Details of all the children in the organization shall be submitted once in 3 months to Child Welfare Committee and Director, Department of Women and Child Development in the prescribed format.
12. It shall abide by the directions issued by the State Government from time to time.

**Registration of Child Care Institutions is mandatory under Juvenile Justice
(Care & Protection of Children) Act, 2015,**

**who fails to comply with this shall be punished with imprisonment which may extend up to one year
or a fine of not less than one Lakh rupees or both**
